		<ul> <li>Mary Berryman Agard, consultant for the Cultural Plan, presented an update about work-to-date on the City's cultural plan:</li> <li>1) Met with city IT staff about anticipated needs throughout the plan and established a "My Account" wherein interested parties will be updated.</li> <li>2) Drafted 3 electronic surveys - One for consumers, one for artists, and one for creative workers and not-for-profit arts &amp; culture organizers</li> <li>3) Drafted a toolkit that will allow interested people to assemble any interested group and discuss Madison's arts and culture and report back with data.</li> <li>4) Preparing to present in November at the Mayor's Roundtable.</li> <li>5) Asked the commissioners to consider how they might drive the survey.</li> <li>6) Shared the names of people being considered by the Mayor's office for the steering committee.</li> </ul>

MAC administrator estimated that the budget will fall somewhere between \$20,000 and \$60,000 depending on variables such as which conservator/foundry is hired to do the work, how much additional landscaping the community group plans for the project and the size of the endowment for the works continual maintenance.
