The Fire Department pointed out there were 125 kitchen fires since the first of the year. Most of these were caused by careless use of equipment. The bail schedule would be \$0 to \$5,000. The average citation would be \$1,300.

The belief is that people need to change their behaviors and the combination of education and fines should be able to do that. There are risks involved every time a fire company makes a run. Some of the concerns raised by the Board were:

- 1. The wording is very strict and almost any fire would reach the threshold where someone could be cited.
- 2. Looking at the address of the fires, they appear to be in student areas and challenged neighborhoods. These folks could not afford to pay fines.
- 3. The insurance question was raised. If someone were cited, would that allow an insurance company to not pay?
- 4. People will not call the Fire Department immediately, but see if they can put out the fire themselves.
- 5. There are not any other municipalities that have adopted such an Ordinance
- 6. Classically with policy issues, education comes first and if that does not work, then adopt an Ordinance for the fines.
