1. 24477 901 Woodrow Street (C-11-63-2011) Jody Shaw of Potter Lawson appealing NFPA 13:8.15.7.1. The rule requires that overlays/soffits which are over 4 feet wide and constructed from combustible materials shall be sprinklered. The Variance requested is to waive the sprinklers as the exterior soffit is 25 feet in the air. The Madison Fire Department supports the Variance provided the exterior building materials are non-combustible and the soffit is 3/4" exterior sheathing, 20 feet above grade.

Jody Shaw of Potter Lawson appealing NFPA 13:8.15.7.1. The rule requires that overlays/soffits which are over 4 feet wide and constructed from combustible materials be sprinklered. The variance requested is to waive sprinklers as the exterior soffit is 25 feet in the air. The Madison Fire Department supports the variance provided the exterior building materials are non-combustible and the soffit is 3/4 exterior sheathing, 20 feet above grade. The designer stated they were going to use fire rated tongue and groove in the soffit.
