4. 22359 229 West Lakelawn Place - PUD(GDP-SIP), Construction of a Fourteen-Unit Apartment Building on the Acacia House Property. 2nd Ald. Dist.

The motion provided approval with the new elevation. Barnett stated the thinner tower and longer base with CMU as originally presented. With option for the green wall vs. the screen wall, the lattice work across the bike parking area and no EIFS elements in the material pallet as it effects vertical/horizontal details of the east and west elevations, look at durable options like metal panel or darker brick with the final material selection to go back to staff for details as needed and appropriate come back to Commission. Encourage applicant to work out the signage prior to construction.

 3502 Monroe Street - PUD(GDP-SIP) for a Mixed-Use Development with 18 Apartments and 3,400 Square Feet of Commercial Space. 10th Ald. Dist.

The motion allowed for the elimination of landscaping in the terrace along Glenway to allow for the potential of entry and drop-off use at the applicant's direction, the balance of green roof be sized to pick up tray systems with option to look at alternative to sedum and to go back to staff if different brick detailing of one-story bookends along Monroe Street.
