## 4. CHAIR'S REPORT - Susan Zahner - 5 minutes

The Chair reports that the director performance evaluation letter was sent to the city and county executives. Frances Huntley-Cooper has chosen not to be reappointed. A welcome was extended to Alder Matt Phair. Volunteers for the Personnel Committee, to assist the Chair Pat Lasky are Lori Kay and Alan Schwartzstein. Elections for board officers will be held in June and current officers will be listed on the agenda.

Schlenker is leaving June 17 to become Director of Public Health in San Antonio, Texas. Ken Loving, MD and Director of Access Community Health Center, is interested in filling in as Medical Advisor until a new director begins. The medical director signs orders, consults on difficult cases and signs off on clinical policy. Our new liaison in the County Executive's Office is Jeff Kostelic, Executive Assistant ,who used to serve on this board.

Robinson is the program manager for immunizations, STI and HIV. She described a project staff is currently involved in working on disparities of Chlamydia infection rates in Dane County. They are looking at data over the last ten years which shows that in 2010, the incidence rate for African Americans was 10.7 times that of whites. The department is doing the following to decrease the inequity; talking with young African American men to learn more, talking with community leaders to understand the issues, increasing Chlamydia screening, talking to staff in youth groups, and talking to community leaders and community partners. CDC stresses increased screening and treatment. A suggestion was made about working with schools. Our approach will be to teach people to teach about this issue. The Chair complimented the division on another nicely done newsletter.

## 7. ENVIRONMENTAL HEALTH DIVISION - Doug Voegeli - 15 minutes

Voegeli reports that the Well and Septic program is half way through the scanning project. With the onset of spring, there are a number of dangerous animal declarations. Corporation Counsel is looking into extending our enforcement throughout the county. There are increased restaurant closures recently. Madison Kipp Corporation has been in the news and staff will meet with the Mayor tomorrow and with the neighborhood in June to work on the PCE contamination. The coal tar ordinance amendment, which increases the fines, is going through county committees. Kennedy Little League is now being allowed to put in a well if it can deliver safe water. The goose management plan was approved last night at a meeting of the Parks Commission. The two highlights of waterfowl management are oiling the eggs and the round up of geese for harvesting. Kirsti Sorsa, our Laboratory Supervisor, is a member of the committee looking at this issue. It is a public health problem as it causes high bacteria levels and beach closures. The goal is to reduce the number of geese. The board may get calls about this issue so staff will forward the management plan.

# 8. OPERATIONS DIVISION - David Caes - 5 minutes

We expect the transition to last 3-6 months, depending on recruitment, which will be done locally and nationally. The recommendation of the executive team is to rotate the Health Officer duties, probably by month, among the three division directors. The preference of the county is to not hire an interim director. A resolution will come to the June meeting recommending transition management. The position description is being developed by Travis Myren, County Administrator, and will involve review by the director, and the board, via the Personnel Committee. The board will prepare a recommendation to the executives on the transition period leadership. The board is in agreement that any one or all three remaining members of the executive team are qualified to fill in temporarily. Discussion followed on whether a rotating schedule would be the best choice since it may be confusing to people to not have one person identified as leading the department in the interim. Caes explained that one person would be the primary contact for the team to triage where the issue should go. Schlenker sees the big issue is who makes the decision when needed. It has not been discussed if one person among the executive team is open to be named Health Officer. It was decided that the Executive Committee will meet soon to make a recommendation for the transition plan. They would like a recommendation from the director on the transition plan prior to their meeting. It would be good to also get staff input on hiring qualities. The board also wants to be an integral part of the final interview process. It was decided that the Personnel Committee will meet soon and provide input on the recruitment, gualifications, and hiring process.

Duranczyk recommend that these be presented to County's Health and Human Needs Committee as part of their process of having divisions present their work plan. It is important for public health to be on their agenda on a regular basis
