# 6. <u>24290</u> Signature Grant Review

Signature Grant applications were reviewed beginning with Jim Carrier's proposal to create a documentary film entitled, "The Liberian and the Banjo"; followed by a proposal by Sharon Kilfoy to create a mural entitled "Aqui Estamos! The Hispanic World Arrives in Madison"; followed by R. David Shaul et al to create a collaborative mural installation; followed by discussion of the Italian Workmens' Club proposal for their 100th Anniversary Celebration; followed by Opera for the Young proposal to commission "Cinderella" ending up with TAPIT/New Works to prepare and produce a new play "In the Care Of."

The applications were reviewed and discussed, work samples were considered, and individual score sheets were completed by the commissioners. Satya Rhodes-Conway recused herself from the discussion of Jim Carrier's application, Celia Klehr recused herself from the Discussion of Taplt/New Works, Leslee Nelson recused herself from the discussion of R. David Shaul et al's application, Celia Klehr recused herself from the Discussion of Taplt/New Works. Commissioners who recused themselves left the room before the start of discussion and did not vote on that applicant's proposal. They were called back into the meeting after all others had scored their votes. At the end of the review, all scores were tallied, Jim Carrier had the highest average score.

A motion was made by Elson, seconded by Madera, to Approve Jim Carrier as the recipient of the 2011 Signature Grant for "The Librarian and the Banjo." The motion passed by voice vote/other.

## 7. <u>21297</u> BLINK Proposal Review

A motion was made by Madera, seconded by Schweitzer, to Approve the recommendations of the Public Art Standing Committee to fund Tim Sprengelmeyer, Earth Turtle for \$750; Ryan Lawless, Intervention - Building at 710 University for \$750; and Tim Browning, Plane and Penquins on Lake Monona for \$500. The motion passed by voice vote/other.

# 9. 20271 2011 ARTspace Exhibitions

Nelson reported that one of Juliette Crane's paintings was stolen from the current exhibition. The artist claims a value of \$350, which does not meet the deductible. Commissioners expressed sympathy, but agree that nothing can be done. Staff reported the incident to police and will extend their dismay over the unfortunate situation.

A motion was made by Elson, seconded by Madera, to Approve Leslee Nelson's proposal to allow "Cornicopia" a group exhibition in November/December; Minority Affairs Committee and Women's Issues Committee the January/February spot; and reissue a call for artists with a December 1 deadline to attract more applicants. The motion passed by voice vote/other.

#### 10. 24292 Wisconsin Arts Board

Leslee Nelson attended the Wisconsin Arts Board Conference Call and reported that we will experience a 35% cut in our regranting fund. We will probably get \$10,000 to regrant instead of the \$15,000 we have received in previous years. This will start in Fiscal Year 2012. Nelson also passed on an idea from another city's art council where they got a hospital to set up fitness runs between the public art sculptures in town.
