NEW BUSINESS

1. <u>28438</u> Presentation from the Equal Opportunities Division

Marcus Miles, the Equal Opportunities Division Manager, began by explaining the layout of the the EOD. There are 4 staff in addition to Mr. Miles, 3

Investigator/Conciliator positions and a Hearing Examiner. The EOD is authorized to investigate complaints under MGO 39.03. Mr. Miles went on to discuss the process for filing a complaint, stating that anyone at anytime can file a claim, in order to be pursued the claim must meet three criteria, first it must have occurred in Madison, second the claimant must be part of a protected class, and finally they claimant must prove that negative action accurred because of their status as a member of a protected class. At this point one of three decisions is made, either no probable cause, probably cause, or a split decision. Either side has the ability to appeal to the Hearing Examiner if they are unsatisfied by the initial finding. Commissioners asked questions related to issue areas of concern, the EOD investigates claims in employment, housing, and public accommodations, with employment receiving the largest share of complaints. Mr. Miles stated that in the past year the EOD processed 88 claims of discrimination, their top four protected classes are Race, Gender, Sexual Orientation, and Disability. Mr. Miles also discussed the other organizations that the EOD mirrored and talked about the cross filing process with the Equal Rights Division and the Equal Employment Oportunities Division.

Black reported that there was no training on the use of the Automark Machine this time, however he was able to vote early. Black indicated there was some issue with the automark machine not properly marking ballots, however after several attempts Black was successful and able to vote early.

Nuñez reminded commissioners that Statement of Interest forms are due to the Clerk's Office by January, and offered assistance to commissioners in filing online. Glozier reported on several meetings with community organizations over the past month including Chrysalis and the YWCA, as well as the ongoing parks reviews and polling place surveys. Finally, Glozier reported that he received a call from Bryan Cooper, who visited the commission a year ago to discuss the library plans, inviting him, Lucía, and two commissioners to tour

the current progress on December 7th at 1:00 pm. Commissioners were asked to respond to Glozier by Wednesday the 5th if they would be interested in attending.

This award recognizes individuals in the community who have made a difference in regards to social justice in the spirit of Dr. Martin Luther King Jr.

The Commission is still highly interested in the issues of universal design and taxi cab service in Madison. Specific to the Taxi Cab discussion the Commission would like to discuss topics of timeliness of rides, complaints and the complaint process, and the cost of service.
