1. [24233](#) Adopting the Madison Cultural Plan

2. [24851](#) 2048-2100 Winnebago Street - PUD-GDP for a Four-Story, Mixed-Use Building. 6th Ald. Dist.

A motion was made by Huggins, seconded by Barnett, to Grant Final Approval. The motion passed by voice vote/other.

The motion provided for the following:

- A range of 10-15 feet setback at Winnebago Street for room to play, including undulations in the building façade with landscaping/hardscape amenities that relate to the streetscape.
- Four-stories with the request that at the SIP level the parking counts are investigated and return with what is needed for the range of uses proposed and shared parking arrangements.
- Include underground storage, blue roofs, green roof, rain gardens or bioretention swales as stormwater management.
- Consideration for banking some parking stalls.
- Pursue the discussion with Traffic Engineering related to the long-term goals for the courts and addressing the transportation drop-off access opportunities that may occur on Winnebago Street.
- Address massing in relation to the site with the building shape to respond.
- Parking counts are subject to further review of on-site need and availability of on-street parking.

3. [24171](#) 202 & 206 North Brooks Street - PUD(GDP-SIP), Five-Story Residential Building with Fourteen Units. 8th Ald. Dist.

A motion was made by Barnett, seconded by Huggins, to Grant Initial Approval. The motion passed by voice vote/other.

The motion provided for the following:

- Investigate the railing or patio areas, landscape plan and material samples for the fiber cement with either updated renderings or alternative materials consistent with the renderings.
- Look at the edges of the corner element (wedge shape) as one color and bring back alternatives.
- Investigate options for on-site stormwater management.
- Provide better views of all sides of the site.
- Study how materials turn the corners of each elevation.
- Prefer material colors represented in the renderings over that display on the sample board.
