DISCUSSION/ACTION ITEMS

Ald. Bidar-Sielaff asked members if they had any objection to referring #8 (26615) discussion on scheduling a joint discussion with the Dane County Board on areas of collaboration and #9 (26614) discussion on reviewing committee memberships. There was no objection by the members of CCOC.

26621 Poet Laureates Request: Proposal for Future Poet Recitation Dates/Poets

Madison Poet Laureate, Sarah Busse, was present for discussion on this item. CCOC members indicated their appreciation for the May 1, 2012 poetry reading. Lisa Veldran asked if Ms. Busse could email the text of the poem that was read so she could attach it to the legislative file. Ms. Busse also said she would ensure that the text of the poem would be given to the alders at future readings (text of poem, name of the poet, brief biography of poet, and if it comes from a volume of work it would be referenced).

Ms. Busse proposed the following poetry reading schedule:

September 18, 2012: Wendy Vardamann

December 11, 2012: TBD March 5, 2013: TBD June 18, 2013: TBD September 17, 2013: TBD December 3, 2012: TBD

Ms. Busse indicated that she and Ms. Vardaman would look for poets to be invited to read from a diversity of neighborhoods, backgrounds, organizations and experience. Poems would be vetted by them to ensure that they were not too long, appropriate for the occasion, etc. Ms. Busse or Ms. Vardaman would be present at the Council meeting to introduce poet.

Ald. Paul Skidmore asked if while they were vetting they could steer away from political ranting and profanity. Ms. Busse agreed that this would not be an appropriate venue for political recitation or poetry with profanity.

Ald. Shiva Bidar-Sielaff would like to see the poetry displayed somewhere for the public to view.

A motion was made by Ald. Satya Rhodes-Conway, seconded by Ald. Lauren Cnare, to approve the request and the proposed schedle by the Madison Poet Laureates. The motion passed by voice vote/other.

<u>26674</u> Discussion Item: June 28, 2012 Common Council Discussion on Developing a Legislative Agenda

Ald. Bidar-Sielaff incidated that she had been working with Ald. Schmidt and Ald. Rhodes-Conway to engage and secure an outside facilitator for two evening meetings (vs. Saturday meetings). The June 28, 2012 meeting has been scheduled and the next meeting would be scheduled for later in the summer (August). Ald. Rhodes-Conway had already forwarded a name of a facilitator to Ald. Bidar-Sielaff.

Ald. Bidar-Sielaff stated that a survey would be sent to alders prior to the meeting to develop a "bucket list" of issues to provide the facilitator with a framework to develop the June 28 meeting agenda. CCOC members agreed that the issues should be city-wide not district-specific and that 1 to 3 or 2 to 5 issues would be identified from the meeting.

Ald. Lauren Cnare provided the update to the CCOC members. She indicated that members should review the following list compiled by the work group of services/support services used by alders and send her, Ald. Maniaci, Ald. Rhodes-Conway or Ald. King any additions:
