32444 Crowdsourcing and Crowdfunding for Placemaking Projects

Pam Andros of Dane Arts gave a presentation inviting MAC to participate in Power To Give, the County's online crowdsourcing site.

Commissioners asked her to provide more specific information about site traffic and comparisons with other cities and to come back to MAC with a specific request.

2. <u>28021</u> Make Music Madison

Michael Rothschild presented highlight's from Make Music Madison's final report. As part of MAC's responsibility they reviewed and discussed MMM's performance in relationship to their 2013 contract. MAC appreciated that this free event which happens annually on the Summer Solstice (June 21) is an occasion for everyone to make music in a variety of forms, that it affords Madison the opportunity to participate in a global event, and that it is open to the whole the whole city.
