NEW BUSINESS

1. <u>25719</u> Presentation on Accessibility at the Polls and Absentee Voting

Presented by Madison's City Clerk, Maribeth Witzel-Behl from the Office of the Clerk.

Maribeth reported that absentee voting is done at the City-County Building in the City Clerks office. The hours are:

Monday thru Friday 8:00 am - 7:00 pm Saturday 8:00 am - 2:00 pm Sunday Noon - 4:00 pm

On Saturdays and Sundays, entrance to the City- County building will be through the Wilson Street entrance. Witzel-Behl went on to report that all polling places are accessible to people with disabilities. For those with disabilities who are unable to leave their home, live in assisted living facilities or nursing homes, an election official will go to their place of residence and give them an absentee ballot. If a person receives an absentee ballot through these facilities, they will automatically receive an absentee ballot for each election thereafter. However, to remain on this list, they must return their ballot on time. No ID is needed when voting this way. Weitzel-Behl also reported that, for those people who are unable to leave their car, voting at the curb is available whereby a ballot is brought out to a person by an elected official and they can fill out their ballot without leaving their car.

Weitzel Behl stated that there is a training called Voter Education Ambassador Training. This is where deputized elected officials are trained to help people with disabilities vote that are confined to their homes. The training is May 1, 2012 at the Monona United Methodist Church, located at 203 Wisconsin Avenue.
