30768 Update: Council Legislative Agenda Work Group: Alternative Sources of Revenue - Ald. Mark Clear, Chair

Ald. Mark Clear provided an update on the work group's progress. He noted that:

- 1. The work group reviewed revenues associated with refuse and recycling collection
- 2. The new state budget restricts municipalities from increasing existing fees may have an impact for the city
- 3. Looking at regional models for revenue sharing opportunities (Green Bay/Brown County was an example TID relationship)

The work group is still reviewing revenue opportunities and after that review is finished they will provide a report to the Council.
