MMSD chloride handout

Kathy Lake and Ralph Erickson, Madison Metropolitan Sewerage District (MMSD), presented some of the chloride-reduction initiatives MMSD is undertaking in order to reduce the chloride level in their effluent to be in compliance with their DNR discharge permit. The largest source of chloride (60%) at the plant is from water softeners (residential, commercial, and industrial), though all sources are being addressed. A handout summarizing their efforts is attached.

The City is working with a consultant and others to create a Wingra Watershed plan, which will include recommendations for chloride reduction. The City will also be partnering with other municipalities to offer another winter maintenance workshop later this year. The Committee and city staff went through the list of recommendations from the 2006 Road Salt Reduction Report, which was written by a subcommittee of the COE. Staff will update the COE periodically.

The chemical 1,4 dioxane was detected in four Madison wells (9, 11, 14, 15). While the levels were pretty low, Water Utility will continue to monitor the issue. The chemical is used in grease removal and other industrial uses.
