NEW BUSINESS

31106 Sheboygan Gardens

Fey provided history and background related to State of Wisconsin's interest in developing and/or selling property where Sheboygan Gardens is located. City approval of 2006 re-development plan for the site included a condition that final plan would provide for relocation of community garden within the neighborhood, but has expired.

The State of Wisconsin is expected to present a new proposal within the next few months. Fey has asked City Planning to keep the Community Gardens Committee abreast of any action or submittal of plans. A neighborhood planning process is under way for the Hill Farms neighborhood and the question of what will happen to the Sheboygan Garden may be relevant. The committee authorized Fey to discuss drafting a letter supporting the preservation of gardening opportunities in the Hill Farm neighborhood with Mark Woulf in the Mayor's office.

OLD BUSINESS

30629 Parks Department Pre-approved List of Improvements at Community
Gardens

Joe Mathers had drafted a list of frequent improvements made to gardens located in City parks. The Committee agreed with the idea to establish a pre-approved list of acceptable garden improvements and specifications. Leopold will work with Mathers to provide context and framing for the list, presenting a draft to the committee at the September meeting. Parks planner Kay Rutledge will be invited to the committee's October meeting to discuss the list.

Gavin reported on work group's meeting. Their focus is on strategies to sustain existing garden leaders. Strategies that will require funding include sending a delegation of garden leaders to the American Community Garden conference in Chicago next summer, and holding a local garden leadership conference. Strategies discussed that will not require additional funding include: quarterly meetings of garden leaders to share information; re-naming the New Garden Fund and revising materials to reflect support for existing gardens and leadership development/sustainability as eligible activities, in addition to physical improvements and expansions; creating an annual awards and garden celebration forum as a possible fund raiser. The work group will meet again on August 19, and will invite Janet Parker to attend.

The Commission approved a recommendation for \$10,000 to support improvements at the Leopold Park Community Garden, as part of the Leopold/Arbor Hills Neighborhood Planning

Process.
