#### B Superintendent of Parks

Communications to the Park Commission will now be highlighted at the beginning of the Superintendent's Monthly Report. These communications will be items Knepp and the Board of Park Commission President have discussed and may be added to future meeting agendas. The capital budget has passed the Board of Estimates and is now waiting for the Council to accept in November. The Mayor's executive operating budget includes continuation of all services. The plan for EAB mitigation is to treat all treatable street trees with city funding. Non-treatable trees will be pre-emptively removed over a process of 5 to 6 years. Within three planting cycles these street trees will replanted. Many years of planning have gone into preparing to address this issue. Knepp is pleased Charlie Romines has returned to the Park Operations Manager role. Knepp welcomed and introduced the new Recreation Services Coordinator, Tracey Hartley.
