1. 34222 4198 Nakoosa Trail - Building Addition to "Walmart" Including Site

Upgrades and Modifications to the Parking Lot, Truck Docks and Truck Access Routes, Landscaping, Relocation and Comprehensive Design

Review of Signage. 15th Ald. Dist.

2. 36207 829 East Washington Avenue - Comprehensive Design Review in Urban

Design District Number 8. 6th Ald. Dist.

The motion provided for no text on the awning valance and no courtyard sign, with a finding that the "Comprehensive Design Review" standards are met.

## **UNFINISHED BUSINESS**

3. 35617 231 Junction Road - Alteration to a PD(SIP) for Additional Signable Area for "Fontana Sports." 9th Ald. Dist.

The motion provides for approval of "seasonal sporting scenes" but no advertising or merchandising. The display is limited to panels A and H or one large display on panels C, D, E and F. The motion also encourages using color spandrel on the other panels not utilized for seasonal scenes.

4. 33110 330 East Wilson Street - 6-Story, 30-Unit Residential Apartment with 1,907 Square Feet of Commercial Space in the UMX District. 6th Ald. Dist.

The motion **REAFFIRMED THEIR PREVIOUS MOTION** to approve the earlier design of the project for reasons outlined within the report, along with the drafting of an accompanying memo regarding this project and design related issues to be approved by Chair Wagner.
