Ann E. Fleischli of 15 Hiawatha Circle of Madison registered in opposition to the Judge Doyle Square project and wishing to speak. She considers the Judge Doyle Square project a mistake and questioned the integrity of the City's process.

Dan Cornwell of 333 West Main Street of Madison registered neither in support or opposition to the project and wishing to speak. He believes the Madison Municipal Building should remain in civic use and recommended the Committee select a proposal that maintained the building as government offices.

He referred to Page 39 of the staff report and indicated that the Utility's consulting engineer had estimated the target cost to be \$30,000 per stall based on constructing three levels below ground and two levels above ground.
