Wachter walked the Committee through the Draft Senior Report, explaining the challenges with gathering information as much of it is anecdotal and very little is hard data. He also asked how best to define the Senior(SR) market as there is much segmentation - SR led households versus households that include a SR, Heathcare/Hippa concerns, Service Providers only see a fraction of the SR population, fine line between housing and healthcare, etc. He suggested the Committee focus on where their recommendations will have most impact regarding the SR population - those that age in place through assisted living.

Wachter indicated three primary trends in his research that may drive the Committees recommendations: People want to age in place; the aging Baby Boomer population will push housing growth and; the increase in rate of disability as people age.
