20545 State Street Design Oversight Committee Report to MAC

Jill Sebastion presented an update on public art plans for the 700 & 800 blocks of State Street. She showed illustrations of the placement of "The Leaf" and discussed her intentions to include "Philospher's Stone" etched with quotes like the ones at Lisa LInk Peace Park. She has selected specific writings that deepen the experience of the place and have a historic connection. Sofia mentioned that it would be nice to have local writers and younger voices. Patty distributed article from The Daily Cardinal about the streetscaping for that block.
