Directly engage with resident. Example: Lights on SW Bike Path - met with resident at their home to view lights

A motion was made by Ald. Scott Resnick, seconded by Ald. Matt Phair, to nominate Lucas Dailey to fill the vacant Aldermanic District 13 seat. The motion passed on a unanimous vote.
