27505 Sister City Programs Reports

Mantova- Nothing to report regarding Sister City program but did give an update on Festa Italia.

Freiburg- They now have a booth at the Farmers' Market. The President of their organization is currently in Freiburg on a personal trip but will let the committee know what Freiburg has been doing.

Obihiro- Reported that there will be a mental health delegation coming to Madison from July 4th - 13th. Also reported on the Madison mental health delegation that went to Obihiro in May. The Obihiro Veterinary and Agriculture University and the UW-Madison are working on a memorandum of understanding regarding university student exchanges. A potato research team came in mid May and another team will be coming in July to sign the MOU.

Tepatitlán- Sal said that a muralist will be coming to Madison in July and will begin work on the mural at the Madison Municipal Building. The exchange with the Madison artist, Sharon Kilfoy, went very well and the committee is working hard on this upcoming project. DISCRETIONARY FUNDS

Enis asked if the total amount was appropriated by the City Council for 2014 and what is their budget. Frank told us that the City Council approved \$15,000. Lauren asked Enis to find out how much the Mayor requested from this appropriation to be used by his office. Frank thought it was about \$2,500. With the base funding and other expenses, discretional funds would be around \$5,000 for special projects that could be used by sister cities in 2014. Enis said that he would ask that the SCCC be provided with a quarterly financial report.
