CALL TO ORDER / ROLL CALL

APPROVAL OF MINUTES

Motion by Ahrens, second by Rummel to approve. Motion carried.

PUBLIC COMMENT

Betty Chewning (Madison, WI) – Chewning said that she was here because she highly valued the North Plat and the wildlife that resides and uses this area. She said she was concerned that the current draft of the RFP underserved the greenspace and natural area that is already there. Chewning said she did not want to see more pavement in the North Plat. She specifically asked the Committee to remove the requirement that access to Garver not come through the North Plat. She supported proposals that minimized new parking, with points added for proposals that minimized new parking to the area. She said she did not want to see points given to projects that over emphasized coordination and collaboration with Olbrich to the potential detriment of the North Plat. She noted that both Eastmorland and SASY were both underserved with greenspace.

Ahrens noted that the zoning code has a metric for the number of parking spaces needed for a project.

Allgood arrived at 5:42 PM.

Chewning said she would like to see a strong focus on minimizing parking required for the rehabilitation of Garver.

Carl Landsness (Madison, WI) – Landsness reiterated his comments that he made at the previous meeting. He said he had some concerns regarding the

adversarial feelings that were coming out between OBG, the neighborhood, and the Council. He felt that Garver and the North Plat were key opportunities for the entire region. He noted his appreciation with the connection between the North Plat and the waterway.

Lance Green (Friends of Starkweather Creek Association ("FSCA") - Madison, WI) – Green noted the concerns of the FSCA were to continue to value the natural space / green space in the North Plat. He said that green linkages that were provided by the North Plat and surrounding area. He said they would like to ensure that any use of Garver is not noisy or disruptive of the surrounding area while minimizing parking in the North Plat. He emphasized the need for good greenspace and water in the City. Rummel asked if a proposal came in that moved the access point closer to the Kessnich property. Green suggested concerns about how this might work. Wallner asked what use might work for FSCA. Green said some suggestions as a food space were talked about, but he had concerns about loading and other loud, disruptive influences. He focused on something that was quiet and did not involve many customers coming in and out.

Nancy Wild (Madison, WI) – She asked if there was still a proposal out there to build condos on the site. Wallner said that the Committee was starting from scratch.
