APPROVAL OF October 8, 2014 MINUTES

Plan Development

- East-West-North Connections - need more east-west-north connections and the plan could include longer term connections, for example, through the railyard and other existing development. Options might include extension of 6th St. through the railyard or 3rd St. 6th St. might make more sense as there will be a stoplight added at the 6th St./E. Washington Ave. corner. This may or may not increase traffic through the area.

6th St./Pennsylvania Ave. intersection should be improved as its very dangerous and is commonly used to travel from planning study area to the east-west-north. Suggest a stoplight at this intersection (Traffic Engineering: need to weigh safety concerns for vehicles; WI DOT programmed it to stay as it is; can review this option).

East-west-north connections need ped/bike connections, especially for kids trying to access Sherman Middle School and Shabazz High School.

Include Sherman Flyer in the neighborhood plan.

- Demetral Park
 - Sarah Lerner, Parks Division, presented the Demetral Park Master Plan and took comments from the SC on potential changes to the park.

- Demetral Park Public Meeting, October 20th @ 6:00 P.M., Emerson Elementary School, Library Media Center, 2421 E. Johnson St. to explain play equipment improvements that are part of the approved 2015 Park Division budget.
- Demetral Park is a community park serving the nearby neighborhoods and larger city. The portion north of 6th St. is maintained by the Parks Division and south of 6th St. is maintained by Madison East High School.

Committee comments

- Demetral Park is the biggest area of City real estate within the planning area, yet its not a destination.
 - Add entrance signage to park from bike path off 6th St. and review route through parking lot to the rest of the bike path for potential improvements - maybe way finding signage.
 - Add workout stations, slack-lining, bocce ball court, official astronomy viewing site immediately north of baseball diamond on East High Athletic section of park.
 - Shelter is not inviting, ugly and dark. Transform it into a multi-use shelter that attracts a greater diversity of positive events and activities. Parent play-groups currently use it.
 - Enhance Pennsylvania corridor along park with plantings, sculptures, natural prairie, berming, rain garden. Make it low-maintenance as Parks has very limited resources for maintenance - would largely be volunteers.
 - Community gardens could be explored again - there is two feet of clean fill on top of the landfill material and should check with DNR concerning gardens and other digging.
 - Raised garden beds may be more feasible and desirable, next to the dog park perhaps.
 - Rocket composter/bio-digester located next to gardens.
 - Lighting - crime prevention through environmental design guidelines indicate that any lighting should not create shadows where people can hide; perhaps try solar lights that are embedded in the bike path, as in other parts of the City.
 - Lighting needs include the shelter, football field, bike path.
 - Explore connectivity improvements between Demetral Park and Sherman Ave. to make the park more accessible, and then maybe it will be better utilized.
- Emerson Playground
 - 2012 Park Master Plan indicates that the planning area is not deficient in park space.
 - Community Development Block Grant (CDBG) policy that CDBG dollars cannot be used for playground improvements in an area that is not park deficient.
 - Mike Miller, City CDBG Office, indicates that the main issue concerning CDBG funds as a potential resource is that this is school district property.
 - Miller recommends using adopted neighborhood plan as a vehicle for raising other funds to improve the playground.
 - CDBG funds dedicated to the neighborhood planning process: \$145,880.
 - CDBG funds should be spent, or contracted to be spent by the end of 2015.
 - Some examples of what was funded through past CDBG neighborhood plans:
 - Emerson East-Eken Park 1998 - pedestrian lights along North and E. Johnson Sts., Eken Park sun shelter, neighborhood welcome signs and information kiosk, bike path connections at Demetral Park and East High.
 - Northport-Warner Park-Sherman 1992 - Warner Park Community and Recreation Center.
 - Northport-Warner Park-Sherman 2009 - FEED Kitchen, branding with artistic images (bus shelters for example).
 - Arbor Hills-Leopold Neighborhood Plan 2013 - Aldo Leopold Park Community Garden and sun shelter, low-interest home loans.
 - Potential for EEPY 2015 CDBG funds - commercial incubator; gateway entrance branding with artistic images; community composter/bio-digester in Burr Jones Park or - associated with the public market; placemaking, community gardens and bio-digester at Demetral Park; affordable housing related projects.
 - Potential redevelopment areas
 - Area 1 - add option for the east corner, Wisconsin Vision building.

- Area 4 - what is the current density of the existing building? Determine how much parking is needed if keeping this building. Consider architecture on this site that ties it to the lake, sailboat theme, etc. Propose a ped/bike connection to Fordem Ave., determine who owns the land along the Yahara from Area 4 to Fordem Ave., add connection (s) to public market site.
- Area 5 - need to check feasibility of stormwater management channel with the DNR. Re-orient corner building at Fordem/Sherman to create a flatiron look. Start with option to close Sherman Ave. as Option 1.
