<u>37963</u> JDS Ad Hoc Committee Report: Judy Karofsky, Committee Chair

The committee discussed timing, message sequencing and composing a letter from the Board to be distributed to Council. When the project proposals come in City staff will vet the proposals, interview the companies and then present summaries of the proposals to the Board of Estimates. The BOE will be recommending one of the JDS proposals to the Common Council. There will be no other committees involved. The city staff will negotiate with the winning company.

Verveer informed the board that the new alders recently elected to the council will be participating in orientation that includes a JDS project discussion led by George Austin and Mike Verveer.

This committee will meet again the week before the next board meeting.

37964 Finance Report: Kathi Hurtgen, Associate Director - Finance and Operations

There will be no finance report this month due to the same issues experienced the last few months with the new financial software. Staff is continuing to work on the reporting system. Here are the preliminary findings:

The budget is 1% behind in revenue; however, April and May should bring increased revenue.

Expenses will be up due to unexpected increases in the steam bill and retirement payouts.

The City Finance Department is in the process of entering budget information in the system. It is hoped that Financial Statements will be available at the next Board Meeting.

Monona Terrace Finance Department has calculated the Gross Revenue per Square Foot of Rentable Space for Monona Terrace over the last 3 years. In comparison to the "Small Convention Center averages" provided by the International Association of Venue Managers, Monona Terrace has exceeded the benchmark in every aspect. This is true even in 2014, which only included 11 months of business due to January's close for renovations.

Booking Pace Update: Bill Zeinemann, Associate Director - Marketing and Event Services

Meetings, which last month were reported behind pace by 20, have started coming back on track this month, now only behind pace by 10 with 194 of a budgeted 205.

Banquets are strong with 213 of a budgeted 212.

Conventions and Conferences are at 62 of a budgeted 63, and if last year's trend continues, groups will be spending more than expected once onsite.

The GMCVB has been doing really well competing for business, recently obtaining 2 important contracts.

2016 convention booking pace is ahead of schedule, already near 31.
