1. 38611 Presentation on the Proposed 2015 Funding Process for the 2016 City Budget

Jim O'Keefe stated that we had hoped to convene all four committees to take up this resolution, but in the last few days, lost quorum on all committees but the Community Services Committee. Committee on Aging took this resolution up earlier today, and recommended adoption.

Jim discussed the plan for the summer funding process. We will publish an RFP for adult senior and crisis support services. We will continue funding on all other 2015 contracts at their current funding level for 2016. If there are any substantial changes to any program, we will bring it before the committee. We anticipate the same amount of money for 2016 as we had this year. There may be the potential for adult senior and crisis support programs to request more which would go on a B-list. All of this work will be done in early-mid August.

Laura Noel walked through the proposed timeline for the funding process. Applications will be published on June 19, and due on July 10 for continuing programs, and on July 17 for adult seniors and crisis support programs. The committee meetings will be at the end of July or early August. We hope to get the recommendations to the Mayor by August 14.

If you move to approve the funding process, you will be moving to approve the goal statements for Crisis Support and Adult Seniors.
