## <u>38010</u> Proposal for Letter Regarding Prevailing Wage Bill

Davis explained the type of contracts that are required to use prevailing wage and that in addition to reviewing payroll, the Department of Civil Rights conducts onsite reviews to make sure employees are making prevailing wage. He explained there is currently a bill at the State that would eliminate prevailing wage. There was a discussion on the benefits of prevailing wage, including: providing a level playing field because a flat wage is required, helps with wage disparities. Ketcham would like to draft letter, Ald. Eskrich volunteered to sponsor a resolution at Common Council if time would permit. Nuñez said the department can draft and email letter to the Commission for review and input. McGilligan asked it be noted in letter that removing prevailing wage would perpetuate disparities. McInnis made a motion to write an op ed from the Commission to Madison newspapers and the Milwaukee Journal Sentinel, the motion was seconded by Ketcham. Motion passed by voice vote/other.

Davis gave an overview of the disparity study and the background of how the study was performed. He explained the final report has been delivered and posted to website. There was a discussion about the City of Madison showing the lowest numbers of availability seen by the consultant; there are more minorities in other industries and less in construction which is the opposite of most cities. The report shows the lack of a level playing field, but with such low numbers it is very hard to find a disparity. Davis reviewed the twenty-eight recommendations provided in the study as next steps and potential actionable items for the City to consider. There was a discussion about next steps, including: to ask Keen about realistic numbers of availability for the City to aim for, to work to develop potential businesses and existing S/W/MBE. Alder. Eskrich mentioned partnering with other agencies that are already doing the same thing to work more effectively.

He also reported on the AASPIRE internship and the public relations project she is developing. Some of the projects on the horizon are: Judge Doyle Square, Royster Clark, Rethke development, and Truax development.
