A motion was made by Kim Genich, seconded by Matt Phair to approve the minutes from April 16, 2015. Motion passed by voice vote.

2. 38016 Discuss and Recommend Applications for Funding

A motion was made by Dan O'Callaghan, seconded by Matt Phair to recommend for approval the staff slate of recommendations except for The Playing Field, which will be voted on separately.

The commtte discussed the staff recommendations, and asked CDD staff questions about various applications. The idea of giving more smaller \$5,000 grants instead of larger grants was discussed. They also talked about how much harder it is to fund the larger proposals due to lackof funds.

An amendment was made by Dan O'Callaghan, seconded by Matt Phair to

make the following changes to the staff recommendations:

- +\$5,000 to Asset Builders
- -\$12,900 from Bayview Foundation
- -\$5,000 from Center for Families
- -\$2,000 from Common Wealth Development
- -\$8,000 from Madison-area Urban Ministry
- +\$11,600 to River Food Pantry
- +\$10,000 to Science and Math for Everyone

A friendly amendment was agreed upon by Dan O'Callaghan and Matt Phair, to leave Science and Math for Everyone at \$0 funding, and restore Madison-area Urban Ministry to \$8,000, so the changes to the staff slate will be as follows:

- +\$5,000 to Asset Builders
- -\$12,900 from Bayview Foundation
- -\$5,000 from Center for Families
- -\$2,000 from Common Wealth Development
- +11,600 to River Food Pantry

The amendment passed 4-1.
