This alters the last paragraph of section 3.4(a) of the amended and restated development agreement after the word "through" in the second line, add the following:

Finally, as a condition to receipt of the Jobs-TIF, Exact will (a) commit to support diverse hiring through the establishment of aspirational hiring goals for the business units in Judge Doyle Square, reporting to the City on the progress on theses hiring goals and the establishment of partnerships with community organizations and their existing relationship with the Urban League of Greater Madison according to a memorandum of understanding in a form to be agreed upon between Exact and the City (the "Hiring Diversity MOU") prior to the Project Commencement Closing; and (b) prepare a transportation demand management plan (the "Exact TDM Plan") that will be submitted for the City's review and approval prior to the Project Commencement Closing.
