1. CALL TO ORDER / ROLL CALL

The meeting of the Equal Opportunities Commission was called to order at 5:07 P.M. with Bill Fetty, President, presiding. Attendance followed:

2. APPROVAL OF MINUTES

Zach Madden moved to approve the minutes of the October 15, 2015 Equal Opportunities Commission meeting. The motion was seconded by Adam Brabender, and passed by voice vote/other.

No additional nominations were made from the floor. The Commission casted votes via secret ballot, which revealed seven votes for Corinda Rainey-Moore and two votes for Moriah Grace. Corinda Rainey-Moore accepted the position of Chair.

Vice President was the second Officer nomination on the floor. John Quinlan nominated Moriah Grace, which was seconded by Susan Schmitz. Moriah Grace accepted the nomination. Lucía Nuñez called for nominations two additional times. No additional nomindations were made from the floor. The nomination passed by voice vote/other. Moriah Grace accepted the position of Vice President.

Secretary was the third Officer nomination on the floor. Adam Brabender nominated himself, which was seconded by Sean Saiz. Corinda Rainey-Moore nominated John Quinlan, which was seconded by Sean Saiz. John Quinlan accepted the nomination. Lucía Nuñez called for nominations two additional times. No additional nominations were made from the floor. The Commission casted votes via secret ballot, which revealed three votes for Adam Brabender and six votes for John Quinlan. John Quinlan accepted the position of secretary.

At-Large Representative for the EOC Executive Committee was the fourth nomination on the floor. Bill Fetty nominated Adam Brabender, which was seconded by Moriah Grace. Adam Brabender accepted the nomination. Lucía Nuñez called for nominations two additional times. No additional nominations were made from the floor. The nomination passed by voice vote/other. Adam Brabender accepted the position of At-Large Representative.

At-Large Representative for the EOC Executive Committee was the fifth nomination on the floor. Charles McDowell nominated Zach Madden, which was seconded by Adan Brabender. Zach Madden accepted the nomination. Lucía Nuñez called for nominations two additional times. No additional nominations were made from the floor. The nomination passed by voice vote/other. Zach Madden accepted the position of At-Large Representative.
