Daine asked why the drain tile wasn't installed originally. Erdman said the apartments have been there a long time and there have been some drainage issues. 30+ town homes on park in Darbo/Worthington, corner of Webb & Rethke.

Guerra asked whether the contractor is a minority business and if there were bids.

Erdman said the Department of Civil Rights (DCR) gives us a goal for minority hiring for general contracting. Have to do outreach to list. City has fairly robust standards. Would have given notice to small businesses and minority businesses on our list.

RP's Pasta: As they went back through with the City Attorney, the City Attorney was not comfortable with that. BOE recommended approval, Bruns did not want to sign agreement. Negotiations being discussed. Will probably get sent back to Council as reconsideration of the prior.

Eskrich asked what structure are we comfortable with that we have enough of a guarantee.

Lofton said she is concerned about jobs obligation.

Gilmore said he would like to have a discussion of how we might engage the local community residents in some of our policy deliberations. Need to be intentional about this. How is the local citizen's voice being recognized here? Help us to be informed about some of our decisions. Diversity of input.

Guerra said housing issues usually go to Housing Operations Subcommittee. What can we do to be more proactive in development? What can we be doing on north side to create more jobs and better housing - discussion with stakeholders.

Gilmore said we need citizen input on a regular (maybe quarterly) basis from residents who are directly impacted.
