E.1. <u>42189</u> Update on the Neighborhood Traffic Management Program (NTMP) and Low-Income Neighborhoods - PBMVC 03.22.16

Cell phones were brought up as a tool on how to encourage more people to participate in surveys on traffic calming projects. The cell phone survey capability will be reviewed with the Information Technology department, where they can then go over their options on implementing such a system; should know more about this possible option by late summer or fall.
