Legislative Update (December 2015) - Nicholas Zavos, Mayor's Governmental Relations Officer

Nick Zavos, Governmental Relations Officer, provided an update to CCOC members on the following bills in the State Legislature:

- 1. AB 583, prohibiting a municipality from prohibiting or restricting persons from renting out their homes for 7 or more days.
- 2. SB 479, Allowing towns in Dane County to withdraw from County zoning.
- 3. SB 445, Prohibiting Municipalities from regulating landlords and implementing rental inspection programs; requiring owner consent for historic preservation designation.
- 4. AB 582, Property rights and how assessed when platting undeveloped lands
- 5. SB 314, prohibiting persons from acquiring land owned by state and local governments through adverse possession.
