WHEREAS, from a competitive standpoint Wisconsin motorists and other users of Wisconsin highways pay significantly less than any of our neighbors when you combine the annual cost of the state gas tax and vehicle registration fees [ADD: is combined]; and,

NOW, THEREFORE, BE IT RESOLVED by the City of Madison urges the Governor and Legislature to #JustFixItWI and to agree upon a sustainable transportation

solution: one that includes a responsible level of bonding, [ADD: and reliable state funding for local road improvements], [DELETE: addresses] [ADD: provides adequate] local transit funding options [ADD: including regional transit authorities, high-speed commuter rail and bus rapid transit,] and adjusts our user fees to adequately and sustainably fund Wisconsin's multi-modal transportation system. Furthermore, the City directs the Clerk to send a copy of this resolution to our State Legislators, Governor Scott Walker and the League of Wisconsin Municipalities.
