# 6 2016 Golf Section Recap

West Golf Operations Supervisor, Ryan Brinza and East Golf Operations Supervisor, Theran Steindl updated the Golf Subcommittee on the 2016 season including, staff changes, outing promotion, labor recruitment, golf tournament outreach, advertisement, Ray Hearn's progress with Yahara improvements, The First Tee programming, facility improvements, Sue Shapcott's Golf Revolution programming and the new full swing golf simulator programs that are coming up for the winter.

## 7 2016 Rounds, Revenues, and Expenses

West Golf Operations Supervisor, Ryan Brinza and East Golf Operations Supervisor, Theran Steindl updated the Golf Subcommittee on the 2016 rounds and revenues information noting that at the time of the subcommittee meeting the golf program had surpassed its 2016 revenue goal of \$3.2 million. Discussion regarding 2016 expenses began and Subcommittee was informed that the bottom line numbers would most likely not be available until next golf subcommittee meeting.

Discussion regarding fees was held. Golf Staff proposed a 10% increase in season pass rates while keeping greens fees the same. The Golf Subcommittee approved the 2017 fees with the exception of the Season Pass rates. Season Pass rates were advised to remain the same. The Golf Subcommittee advised golf staff to eliminate the "Season Kickoff Party" in 2017 instead of raising season pass rates by 10%. Motion made by Smith, seconded by J.
