## **COMMITTEE REPORTS**

3. 44416 Report from the Madison Police Department

Lieutenant Donahue from the Madison Police Department shared the 59th Pre-Service Academy was recently sworn in. There are 23 new officers with the average age of 27 and the class is forty-three percent female. There were over 700 applicants.

Sergeant Tieu was selected as the new Use of Force Sergeant. He has worked in training for many years. He will be responsible to review Use of Force actions that take place on the street and will publish Use of Force summaries quarterly.

4. 44417 Report from the Madison Fire Department

Assistant Chief Langer shared a recruit class of 20 will begin on October 3 with a graduation on January 13.

There will be an emergency response tabletop taking place on 9/29 where multiple police and fire agencies will work together as well as various city agencies involved too.

Alder McKinney attended the police swearing-in ceremony and was impressed by the diversity of the group and their backgrounds. Alder McKinney mentioned the need and importance of PSRC and for a committee as such to be present in the community to listen to the voices and people the community serves. She would like to see more involvement with the committee and will work towards the Council referring more items to PSRC.

Alder Hall shared there was a chat with the Chief session that took place at the East District on 9/8. She mentioned Captain Snyder will be the East District Captain in 2017 with Captain Schauf going to Training.
