If alternative protected parking arrangement is considered, there is still a cost to finishing the basement. Other agencies such as Fleet, Streets, Engineering, and Water Utility have protected parking for vehicles. Capt. Lengfeld said police districts do not have protected, or separated parking, which results in squad cars parked next to civilian cars in the parking lot. Motion made by Ald. Demarb to include recommendation the Finance Committee consider the cost of underground parking. No second. Motion not accepted as friendly amendment.
