Rolfs provided an overview of the proposed project plan amendment. Mertz raised questions about how the City overspent the TID by \$25.9 million. He said that MMSD will be asking the City for a written explanation about how this occurred and what would prevent this type of over expenditures going forward. Casper echoed his sentiments. Gromacki noted that the annual audits, provided each year by TIF law to overlying jurisdictions, had flagged these over expenditures since they occurred. Schmiedicke noted that these expenditures were a mix of backstops on bonds and hard project costs. Rolfs also said that there were no current City Staff who were serving the City when the decisions to overspend the TID were made.

Rolfs provided an overview of the proposed project plan amendment. Mertz asked if there were other donor TIDs considered. Gromacki said that TID #42 was considered, but it was not as high performing as TID #41.

DISCUSSION OF JOINT REVIEW BOARD PUBLIC MEMBER REPLACEMENT

Poulson noted that he has served nearly 12 years on the Joint Review Board and is looking at stepping down. Poulson asked if the Joint Review Board wanted to discuss a process to find his replacement. Gawenda noted that some Joint Review Boards in the County asked for volunteers at Organizational Meetings, and then selected on from there. Mertz talked about asking for an open call for potential Board members. Staff was asked to find out who is eligible geographically to serve as the public member. Motion by Mertz to authorize Poulson to work with City Staff on means of selecting a new public member, second by Casper. Motion carried.
