SEED Grant Changes 2018. Reistad provided an overview of the SEED grant program, application process, and grant material changes.

Members explored what kind of questions are asked in the information session, turnout which is generally 8-15 people, though others may not be able to attend for various reasons), and the process which involves a "speed dating exercise" to help grantees learn from each other. Suggestions were made to to implement an FAQ or "guiding questions" resource, and to consider recording the meeting for those unable to attend. In a discussion of whether past experience of grantees could be instructive, it became clear that funded applications could easily be made available online; this history of successful projects could also be highlighted to illustrate the value of the program. Consider preparing a 5-year progress report to describe past grantees more fully and support potential for expanding the program.

49950 Food Waste Task Force January 2018

The Food Waste Reduction Task Force held a meeting on Wednesday, December 13. We had a short discussion about the progress of the interns working on the Food Recovery Guide. They should have a draft of the guide for us to review in January and to ensure that the interns are back in town after winter break to meet with us, and to give us some time to review the Guide before we meet, we decided to move our January meeting to Wednesday, January 24. We also discussed school district rules for what happens to uneaten/untouched food within schools and the allowance of sharing tables. We decided to invite Steve Youngbauer from Madison Schools to an upcoming meeting to gain a baseline of knowledge from which we can move forward with any plans or recommendations. Chris will also continue to work with George on WasteCap's offer to partner on a food waste symposium in 2018.
