46860 GMCVB Update: Deb Archer, President/CEO, GMCVB

The GMCVB is working on the formation of a Chapter of Hospitality Sales and Marketing Association in Wisconsin.

Work is being done with Madison College to create two classes that deal with hospitality leadership and services.

A new Ad Agency has been hired to help with branding efforts. In concert with this the GMCVB is working with the Experience Institute, receiving experience training so they can learn to build immersive experiences for visitors.

Along with developing some new summer events, the GMCVB has partnered with 16 state CVBs to do radio and TV spots about tourism and its importance to Wisconsin. These will be aired in May.

Monona Terrace and the GMCVB are working together to reexamine the booking event assistance fund formula. The formula needs more flexibility;

additional factors should be taken into account when determining if an event should be awarded assistance funds.

 Wilson Street Contra-flow Bike Lane: Bill Zeinemann, Associate Director -Marketing and Event Services

The common council will be considering a proposal to test the feasibility of a contra-flow bike lane on Wilson St. This test lane will be on the south side of the street and will eliminate all the parking and loading zones on that side. This presents a difficulty for several businesses, and Monona Terrace's partner the Hilton, busses and box trucks use that side of E. Wilson as a loading zone regularly. Monona Terrace convention attendees would be affected by reduced access to the Hilton. The board decided not to weigh in on this issue at this time.
