1. 44656 CDBG Chair Report

D O'Callaghan would like to congratulate all of the alders on their re-election to the Common Council. On a sadder side, Russ Whitesel passed away. He was a former member of the CDBG Committee.

Possible cuts to the CDBG and HOME programs being discussed at the federal level would be very harmful to the community. We as a committee need to find a way to inform the community and representatives at the state and federal levels what is being accomplished with these federal funds. With CDBG Week coming up, committee members should reach out to the community and sub-recipients to hear their stories.

BUSINESS ITEMS

2. 46727 Housing Development - goals and priorities

J O'Keefe gave a brief overview of draft RFP – it is still a work in progress. We want to focus discussion on the first two pages of the document and gather information from committee members.

The goal is to provide the following:

- Adding Affordable new units
- · Improving affordable units
- · Preventing loss of affordable units with POA's that are set to expire

Produce more quality rental housing that is affordable to lower and middle income households and located in areas of the city that are well connected to common amenities such as public transportation, parks, schools, health care, food venues, employment, etc.

- Will include a map identifying eligible or preferred areas for new units that are amenity rich – and not primarily-low income areas.
- Need to be clearer on requirements for new construction and and rehab

Improve the coordination between affordable housing developers/property managers and housing support agencies in order to support housing stability and prevent homelessness.

Encourage developers and services providers to team up with tenant selection criteria

Example - The Stone House - Road Home partnership

Other questions/suggestions:

- A desire for more precision and clarity regarding what City is incentivizing
- Punch up the goals and accomplishment section
- Is there a way to have more 3 bedrooms versus 1 or 2 bedrooms for families?
- What is our end goal?
- Are project based vouchers used for these projects? Yes, they have been used in all of these projects and will be in the PSH phase 3 as well.

- Will these projects be mixed income?
- Is it possible to have developers involved in developing the RFP? There has been consultation with group 3rd Sector for input.

O'Keefe and Morrison welcome any additional comment and anticipate bringing a revised draft to next CDBG Committee meeting for review and approval.
