Linette Rhodes introduced the CAPER document and discussed the new and improved way staff would like to present the activities of the CDBG Unit in 2018.

Ethan Tabakin presented on the last year in affordable housing, as well as a look back at the last five years.

Linette discussed the consumer lending programs (formerly known as the direct lending programs) Many loans came in through the City's Building Inspection Unit last year. She gave the statistics of the Downpayment Assistance programs.

Ethan then presented on the non-housing related projects in the CDBG Unit--Wilmar Neighborhood Center and One City Schools acquisitions, More Smiles Wisconsin and Main Street Industries. He also reviewed the neighborhood planning projects that we funded projects with CDBG funds--Emerson East-Eken Park-Yahara Neighborhood Plan and Darbo-Workthington-Starkweather Creek Neighborhood Plan.

Linette reported on the economic development activities of the Unit--job creation, small business development and adult workforce programs.

Sara Lim presented on the City's homeless services we funded in 2018, their goals and activities, partner agencies and system performance.
