Manning discussed recent expiration of member terms. Muriel Simms and Diane Adams had originally planned on extending their terms, but have since decided to let them expire. Christine Coke is a new member that will begin at this meeting. Another member application has been submitted. The final open seat is the citizen member slot. Members should pass along potential candidate names to Coral. Staff may contact Dr. Dipesh Navsaria at UW Madison for candidate suggestions.

Christine Coke introduced herself and discussed her experience with 4C and YoungStar. She is currently a Bilingual Technical Consultant for Spanish speaking family child care.

Templin explained that the City of Madison allocates funds to Satellite Family Child Care to handle family child care accreditation. Satellite is part of the larger Dane County Parent Council organization. Amy Christianson gave a brief history of her career in child care. Dane County Parent Council has rebranded itself as ReachDane. Christianson discussed the scope of the Satellite program. In 2017 a review of FCC standards is planned to sync with the recently updated City of Madison accredited standards.

The Northside Early Childhood Zone initiative is working to enhance opportunities for families and family child care centers. Manning informed the group about the Northside Child Care Action Team gathering data to be used to address gaps in child care on the Northside.

Manning discussed 4th quarter child care assistance data. The drop in the number of children served is due to the removal of those no longer using child care, no longer qualified for the program or not interested in continuing with the program. The waiting list is also being reviewed to updated current needs. The formula for funding needed per family is complicated based on age and needs of children and families. Some families may have several young children in care while others may just have 1 or 2 school age that need summer care only. During staff transitions there were families and children listed as on the program that were not participating and not receiving funding. These clerical items have been addressed. Staff works closely with centers to ensure accurate enrollment data. The review of current program participants and waiting list families will allow more efficient use of available funding.

\$50,000 has been set aside for special circumstances including domestic violence and homelessness. If funds are not used by September 1st they will be rolled back into the budget and used to pull families off the waitlist. Another \$50,000 is reserved for Northside Early Childhood Zone.

4. 46020 2017 Tuition Assistance Rates

Manning discussed the rate survey conducted by George Hagenauer from 4C. George asks all centers but only uses information from accredited centers who respond for the rate comparison. Accredited centers are required to respond but family accredited programs are not. The committee discussed the possibility of asking Satellite to require that of their accredited programs.

Those families with rate increases greater than \$25 per week will be allowed to have that phased in over the next 3 months. The 2017 federal poverty levels have not been released.
