Putnam noted that TORC has recommended that existing committees remain until the new Transportation Director is hired. Putnam asked if PCFPWD members were willing to serve into 2018. Kunz stated that para transit is going to be curb to curb starting next February and will be cash only. Kail stated that the state got an exemption for the curb to curb for winter months. She doesn't know what the status is of this exemption. Putnam to check into this. This is imperative for many people such as Community Living Alliance and those with mobility challenges. Kail stated that whether this committee continues into the new year depends on whether transportation is still provided or not. Transportation is a serious concern for all people with disabilities.
