Discussion of potential merge or improved collaboration between Committee on Environment and Sustainable Madison Committee.

Shukla presented background of discussions between himself, Katt-Reinders (Chair of COE) and Alder Wood on merger or better collaboration between two committees. Historically have similar agendas, but COE has focus on water, lake quality and other natural system elements. SMC has broader sustainability focus with an emphasis on energy conservation. Various options were discussed: merging the two committees, holding joint meetings; have cross-over membership on each committee; have different meeting times for the two committees; joint membership on sub-committees formed to address specific topics and leaving things as is. Alder DeMarb put forth the idea of having a joint review team look at the charges/mission for each committee, determine some areas for collaborative work, and invite the Office of the City Attorney to sit in and review ordinance changes that might be necessary if merger arises as an option. The team will target to report back to both committees by the fall. Members should give some thought if they want to be on the review team; DeMarb, Wood, Mitchell, Leeper, Shukla and Katt-Reinders agreed to have an initial meeting to begin the process. Karl van Lith volunteered to staff the meeting(s).

Hoffman will send out a Doodle poll to determine possible alternative meeting times for both committees, as this may be the easiest collaborative item to do quickly.
