- 4.30 (3) (b) 3 Should read "Improvement of any City owned/leased outdoor site improvement project to which there will be public access." Delete "but excluding public right of way, utility easements, and highway easements."

- 4.30 (8) Should the heading "Ownership of complete works of art" should be more clear. Describe ownership. Who owns it. Again, the arts commission questioned why VARA has to be in the ordinance, rather than in acquisition policy documents.

A motion was made by Pino, seconded by Foy, to RECOMMEND TO COUNCIL TO ADOPT WITH THE FOLLOWING RECOMMENDATIONS - REPORT OF OFFICER. - 4.30 (3) (b) 3 Should read "Improvement of any City owned/leased outdoor site improvement project to which there will be public access." 2. <u>28584</u> Review of Arts Budget

Commission reviewed Budget proposal and made the following recommendations:

- \$70,000 Art in Public Places projects
- \$50,000 Conservation of Existing Works
- \$140,000 Public Art for the Public Market
- \$20,000 MURAL ALLEY in the Darbo Worthington Neighborhood
- \$20,000 for the expansion of the Utility Box Wrap Project

# A motion was made by Schrank, seconded by Pino, to Approve the recommendations as discussed. The motion passed by voice vote/other.

3. <u>21297</u> BLINK Proposal Review

Commissioners reviewed BLINK proposals and made recommendation as follows: - Madison Parks Foundation on behalf Bethany Jurewicz - Makeshift Temporary Art Festival: MAC will approve \$1500 in funding. City staff will select pieces that may be placed in public spaces after the festival. Those pieces will be kept up for a longer duration.

4. <u>32522</u> Review Overture Contract

Attorney's office is working on updating the contract to reflect the fact that the Room Tax Committee is allocating the budget to Overture.
