50582 Environmental Components of the Monroe Street Reconstruction

Phil Gaebler of City Engineering presented on the environmental design decisions for the Monroe St. construction project including stormwater treatment and erosion control. The screen structure at Lake Wingra will remove 30 lbs of phosphorus/year. Monroe St. produces 18 lbs of phosphorus a year, so also removing portions of the load from upstream neighborhoods. Other stormwater managment elements include a rock trench, rain gardens, and a bioretention basin. Framed inlet protection will be used on parts of the project for enhance erosion control. Erosion control inspection requirements and frequency were also discussed.
