52104 Update on Ash Tree Removals and Treatment

Marla Eddy of City Forestry presented on the current status of the ash tree treatment and removal program. Treatment program has thus far been successful at blocking infestation from spreading to treated trees. Information regarding the chemical used for treatment and its degradation in sunlight in the leaves was also discussed. Forestry provides an annual update to the Common Council.

<u>52105</u>	Overview of City Recycling Program and Current Practices
	Bryan Johnson of the City Streets department provided a presentation on the current recycling procedures used at the Pelletori sorting facility and background information regarding global recycling markets. Recycling facilities are reporting higher rates of contamination in recycled waste, including food waste as well as bottle caps and other small items that sneak through due to gravity sorting methods used to seperate materials.
