Nicole Solheim from Gorman & Company, and Justin Frahm from JSD planning and landscape architect department, gave a presentation outlining their proposal requesting the existing parallel parking on the SE side of Winnebago Street would be adjusted to angled parking stalls.

Registrant Eric Peterson from Group Brewing LLC, spoke in support of the proposed parking plan.

A motion was made by DeVos, seconded by Alder Zellers, to keep the current configuration, in agreement with the original plan approved by GDP, and deny the proposed angled parking request.

Recommendation to develop a plan for sidewalk width in the downtown area, so that when development occurs the width can be pre-determined. Planning department staff checked with the consulting firm to get an estimate of cost for study, though they were unsure if planning currently had the current capacity to move forward. Alder Zellers requested staff send the correspondence from Planning to the commission members. Loon supports option #2; Fred Fuss neither supports or opposes; Marie Jacobson opposes option #2; Kristin Austin supports option #1; Isabella Matheson supports option #1; Michael Matheson supports option #1; James Wilson neither supports or opposes; Jonathan Gapen neither supports or opposes; Derek L Tyus supports option #1; Justin Frahm from JSD Professional Services Inc registered and was available to answer questions.

Alder Kemble spoke in support of safe transportation facilities for pedestrians and bikes with the added benefit of the additional trees, and said she would be supporting option #2, but with the great concern for the people who live on the 2100 block.

Alder Zellers echoed Alder Kemble in support of option #2. Although she would like to take a foot and put it on the terrace for bigger trees, Alder Kemble prioritized biking, especially winter biking, sympathizing with residents and the impact of event parking on their ability to park near their residence.

Rewey requested canopy trees by taking out the buffer on one side and putting it into the terrace, while still keeping the buffer on the parked car side.

Foster spoke on option #2, believing it to be a higher quality bike facility for the ability to have street trees. Foster stated his belief that a 25ft cross-section for biking, parking and driving, especially with it being a Metro route, is the minimum in order for it to be an equitable all ages and abilities facility.

Alder Zellers moved to make an amendment to the motion to narrow the terrace on the non-parking lane side from 5 to 4 feet, and add that foot to the terrace on the other side so a shade tree can be planted. Foster seconded. The motion failed by the following votes:
