### **NEW BUSINESS**

1. 53904 Reviewing the 2018 Food Cart Review Scores

> The scores for the 2018 Food Cart Review were reviewed. There were two carts that had adjustments to their scores in regards to Health Code deductions. Those carts scores were adjusted and the results were reposted. V2 stands as the final scores for the 2018 Review.

2. 53903 Approval of the 2019-2020 Mall Concourse Vending Site Map

3. <u>53622</u> Amending Section 9.13(6)(a) and repealing Sections 9.13(7)(b)1. and (7)(e)2. of the Madison General Ordinances to clarify the State Street Mall/Capitol Concourse Vending Area boundaries and to eliminate the Langdon Street High Density Vending Area.

A motion was made by Wood and seconded by Gelman to Amending Section 9.13(6)(a) and repealing Sections 9.13(7)(b)1. and (7)(e)2. of the Madison General Ordinances to clarify the State Street Mall/Capitol Concourse Vending Area boundaries and to eliminate the Langdon Street High Density Vending Area. The motion was passed by a voice vote/other.

4. <u>53621</u> Amending 9.13(3)(a)4. of the Madison General Ordinances to create an Umbrella Basic License for non-Mall/Concourse food vendors and making housekeeping changes.

A motion was made by Verveer, seconded by Gelman, to RECOMMEND TO COUNCIL TO ADOPT - REPORT OF OFFICER. The motion passed by voice vote/other.

5. <u>53820</u> Amending Section 31.075(2)(a) of the Madison General Ordinances to increase the permit fee for a promotional banner.

A motion was made by Gelman and seconded by Wood to amend Section 31.075(2)(a) of the Madison General Ordinances to increase the permit fee for a promotional banner. The motion was passed by a voice vote/other.

A motion was made by Verveer and seconded by Wood to create Sections 9.13(1)(a) and (6)(n)6.c. and amending Sections 9.13(3), (3)(a), (5)(b), (5)(c), (6)(h), (6)(i)1. (6)(i)2., (7)(e), (7)(e)1., (10)(f), (10)(g)1., (12)(g), (12)(h)1., (5)(d)5., and 9.54(10)(a)1. of the Madison General Ordinances to increase most street vending license fees and the Table permit fee; and create a system of late fees associated with the licenses.

An amendment was made by Verveer and seconded by Wood to increase Southeast Campus vending fees to \$500. A friendly amendment was made by Wood to increase Southeast Campus vending fees to \$400. This friendly amendment was accepted by Verveer. This motion was approved by a voice vote/other.
