Heinemann and DeMarb recommended that more specific language be used to reflect items already being worked on, particularly the Energy Plan and MOU with MG&E. DeMarb moved and Vickerman seconded that introductory paragraph in Green and Resilient section reference Energy Plan and MOU. Committee approved. Ryan moved and Shields seconded adding a reference to the Madison Sustainability Plan in the introduction of the Green and Resilient section

Ahrens moved and DeMarb seconded other changes. Committee approved changes below.

Under Green and Resilient:

Strategy 1: Add an Action stating, Keep residential water affordable and change Project Home action to expand who City and residents could work with to help with residential water upgrades.

Strategy 2: Commit to phosphorus reduction in lakes, regardless of changes in federal requirements. Add additional action: City should participate in phosphorus removal program for "legacy phosphorus" in lake beds and streams, within the county and city environs.

Strategy 3: Strengthen language by adding Energy Plan target info-100% Renewable energy and Zero-Net carbon emissions. Move Strategy 3 to the Number 1 position in that part of the document-change wording to. Implement the Energy Plan to reach the goal of 100% renewable and Zero-net carbon emissions. Also accepted Guidelines for agricultural best practices.

Neighborhood and Housing section; Under Complete Neighborhoods reinforce the need for affordable senior housing and senior care services within neighborhoods. Use language to focus on the life-cycle of residents.

Public Comment on this specific agenda item. Resident (Hank). 100% renewables goal ignores direct generation of electricity outside of our area. 63% of MG&E electricity derives from coal and that needs to change. As an affluent city we and others affluent cities account for 60% or more of emissions. Infrastructure, the needs for food, goods and services need to take into account these remote emissions and address them. The City needs to look at carbon pricing to offset these emissions.
